1. The Government of Bangladesh (GOB) has received financing from International Development Association (IDA) toward the cost of the Coastal Embankment Improvement Project, Phase-1 (CEIP-1). The overall objective of the CEIP-1 is to increase the resilience of coastal population to natural disasters and climate change. The Project is being implemented by Bangladesh Water Development Board (BWDB) under Ministry of Water Resources (MOWR). BWDB will utilize part of the proceeds towards payments for an Individual Consultant (International) who will provide technical and professional support to ensure safety, economy, state of the art construction/ improvement of the embankment system and water management practices inside the protected areas while ensuring social and environmental safeguards.

2. BWDB now invites eligible individual consultants (National and International) to submit their Expressions of Interest (EOI) in providing the services mentioned below. The consultant should submit complete CV with detail information about employment history with duties and responsibilities, academic details, major publications (if any), contact address including telephone number and e-mail.
